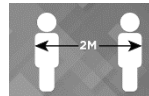


Components of a Safe Learning Environment

FCCS Covid-19 precautionary measures taken

Students & Parents:

1. All students will enter & exit through main (North) doors
2. It is recommended that parents drop off in front and allow the student to enter the building independently.
3. Students will wash hands regularly throughout the day, including before and after PE, Recess, & Lunch
4. To ensure social distancing students will be provided a physical barrier for their work area as necessary
5. Students will not share supplies with each other or the teachers
6. The teacher will use a 70% isopropyl solution to disinfect any technology between each students' usages.
7. At the end of each period, students in grades 6-12 will disinfect each desk with a 70% isopropyl solution.
8. For student pickup during the school day, parents are encouraged to call the office upon arrival at the school. The parent, wearing a mask, may come into the building to pick up the student or the student may be dismissed to the vehicle.
9. Students will social distance in the lunchroom during lunch
10. Each grade (6-12) will be assigned a day each week to be responsible for a "Cleaning Time" This will involve cleaning stair railings, door handles, and lockers. Students are provided proper cleaning supplies. Students will not use toxic chemicals during this function.
11. One time per month, all students will participate in a "Falcon Pride Event" during advisory. This will include cleaning locker rooms, lockers/cubbies, wiping down windows, and checking lost & found for personal belongings. Lost articles will have been disinfected by staff prior to placement in the Lost and Found.
12. If suspected exposure to virus occurs, parents agree to isolate the student and notify the school
13. Students who exhibit the following symptoms of Coronavirus (COVID-19): fever of 100F or more, loss of taste and smell, and shortness of breath. must refrain from attending school. See "Student Process for Returning to In-school Instruction" at the end of this document.
14. Students will bring only cold lunches. Heating lunches and lunch items will not be an option during phase 2

<u><i>FCCS Covid-19 precautionary measures taken</i></u>		<u>Maintenance & Janitorial Staff:</u>
15.	All FCCS Staff & Faculty are trained to maintain a clean & safe environment	
16.	All FCCS Staff & Faculty will take measures to maintain a clean & safe environment by frequently washing hands	
17.	The Housekeeping staff is working to maintain a clean & safe environment for students to learn	
18.	Emergency Stations are in each room near the class entrance. These stations contain a spray bottle with a 70% isopropyl-based solution, Nitrile Gloves, facemask as well as safety vests, emergency binder, safety cards & school map.	
19.	Extra sanitizer stations & sanitizer solutions are located throughout the building for use	
<u><i>FCCS Covid-19 precautionary measures taken</i></u>		<u>Teachers, Aides, & Coaches:</u>
20.	Teachers will train students on proper technique of handwashing and hand sanitizing.	
21.	Barriers for student desks are provided, as necessary, to comply with social distancing in the classroom. They will be disinfected daily.	
22.	Water fountains are not in use; however, bottle filling stations remain open for use	
23.	Playground equipment requires <u>written parental request</u> for the student <u>NOT</u> to use it. It will not be disinfected (same as the city park playgrounds in phase 2)	
24.	Class doors, light switches, doorknobs, desks, countertops, technology equipment, and flat surfaces are disinfected at recess, lunch, at the end of each day by the faculty/staff	
25.	All extra-curricular events, including athletic events and field trips require social distancing or barriers between students as appropriate	
<u><i>FCCS Covid-19 precautionary measures taken</i></u>		<u>Front Office Staff:</u>
26.	FCCS Office staff monitors students for sickness, and will alert families, when necessary, to potential illness or injury within the school.	
27.	FCCS will work with the City County Health Department (CCHD) regarding any COVID 19 cases as required for contact tracing	
28.	FCCS maintains records of all student absences due to illness.	
29.	When students become ill, they will be required to follow specific guidelines for returning to in-classroom instruction. (See Process Below)	
30.	Accommodations for students who are ill or at risk will include electronic access to teachers and to the teacher's daily lesson plans for work to be done while at home.	
31.	Accommodations for teachers who are quarantined or at risk due to suspected COVID 19 infection will include the teacher's ability to remote in to the class and/or asynchronous digital learning.
